

- ^{2.1)} Please comment on specific characteristics of the course that were most beneficial to you:
- - The quizzes were very helpful to understand the concepts and test if we understood the concepts well
 - The professor was very enthusiastic and engaging about accounting which made it easier to stay engaged in the online environment

- Accounting can be a pretty dry subject but Dr. Raval always managed to make class engaging. Additionally, I feel like a lot of professors have been a bit angry with students this semester because our performance is not on par with being in class, which doesn't make the situation any better. I noticed that Dr. Raval was always upbeat and understanding, which is a lot easier to learn from than an angry professor.
- Handouts and professor recordings of the handouts solutions were very helpful.
- Handouts and videos provided were beneficial to me.

- Please comment on specific aspects of the course that need improvement:
- Maybe have a little more explanation or lecturing regarding general concepts (sometimes the textbook can be really hard to understand)
 Decrease the amount of quizzes to maybe once a week
- A little more transparency about exam questions. I understand that Accounting is a cumulative subject, but a bit more forewarning that the exams include questions that are broader than what is in the homework and quizzes would help. Especially since tests make up the vast majority of the grade. Additionally, this is the first class I've ever taken where tests are always formatted just like the quizzes or hw so it came as a surprise.
- I really wish if the professor gives us the option to go back to the previous questions on the exam because due to the limited time pressure I made a lot of silly mistakes and lost a lot of points on the questions I knew how to do.
- Just how the course is taught. At the beginning of the course, the zoom meetings did not relate to the chapter we had read, or were even related to homework problems... Now, there is more instruction and explanation of the topics we had learned. This has helped me quite a lot to understand the chapter more. I just wish the quizzes were given on the continuous class. So for example, after reviewing the topic during the zoom meeting, the quiz should be held on the next class. That's what Professor Melissa did, and it was so much easier to further study and review...

Also, I wish I had all the time in the world to study for only this class, but being an adult leads to having more responsibilities. But because of this, I've learned how to micro-manage my time, and I thank you for that.

- More handout problems would be helpful. Generally, there were only three or four questions for every topic. A brief overview video of every topic would be helpful instead of diving straight into solving the problem. For example in the overview video talk about the key terms and formulas. Then in the next video solve the problems and so on. Maybe also have an anonymous way of asking questions? I think Poll Everywhere is worth looking into. Ask students to rate their understanding of the concepts on a scale of one to five before the quiz then send another poll after the quiz. Also having another day of office hours. For example 2pm-3pm on Monday then 2pm-3pm on Friday. Maybe have a group project too? A part of succeeding in college is studying with your peers throughout the semester so maybe put us in groups at the start of the semester? It will help students connect with one another.
- Needs to lecture because I learn better from actually lecturing rather than just going over the homework or a problem. I only learn aspects from that set instead of the total idea as a whole

- Professor should walk through examples during the class.
- Some of the quiz and test questions were way out of what we were going over class
- Teaching the chapter during class time inside of on our own.
- Tests were hard already, I think there should not be points deducted on students tests for not getting some of the material
- The course was already suppose to be really difficult in person but its felt even more difficult online. The professor keeps saying he sympathizes with our current situations but then turns around and make the test have negative points on the multiple choice section and we are not allowed to go back on questions.
- The tests need to be more related to the course material. Either make course material more challenging so that people gauge how the exams are going to be or just make the exams easier.
- Things that need improvement would be teacher office hours or TA office hours. Since the class is such a difficult class and COVID made things worse I felt like there was barely any help. Teacher office hours were for only 1 hour and once a week. I felt like I basically taught myself all the material. Another improvement would be the scheduling of HW. Our teacher would give us the homework and it felt like we walked into the homework blind. No explanations in class prior to homework. I was self-teaching myself which I don't mind but when there's barely any time to get help from the teachers it made understanding the material that much harder.
